## HOW YOU CAN BECOME A CLIMATE CHANCE PARTNER

*Whatever sector you work in, whatever your objectives or means, we ask that you help us to implement programmes that are necessary to consolidate and grow projects being carried out at local level. Beyond a financial partnership, it is also about finding synergies within your own operations in the service of climate action.*

We offer companies a unique partnership framework:

**STRATEGIC PARTNERS:** for up to €50,000 per year\*, you support all our actions and appear in all our major initiatives (summits, report presentations, etc.).

**OBSERVATORY PARTNERS:** a contribution of €30,000 p.a.\* means that you support the activities associated with our Observatory and appear in all our operations associated with it.

**PARTNERS IN AFRICA:** your support of €25,000 p.a.\* contributes to the mobilisation of climate actors in Africa (coalitions and thematic roadmaps) and you appear in all our related initiatives.

\* Tax advantage: you benefit from a tax reduction equal to 60% of the amount paid (within the limit of 5% of the annual turnover, excluding tax).

For small businesses, specific partnerships can be considered.

All partner companies benefit from a seat on the association's board of directors, alongside other actors committed to climate protection (elected officials, researchers, heads of associations, former ministers and officials of major international bodies). As a platform for high-level exchange, this network of international actors who are very involved in climate action defines the priorities of Climate Chance, in synergy with a steering committee.
