- Feed the [Cartography for Climate Action](#) on our Portal for Action and highlight initiatives emanating from all over the European continent.

Selection Criteria

The contributions will be analysed by Climate Chance's Scientific Committee. This committee is composed of members from the Climate Chance Association and organisers of the Climate Chance Summit Europe 2022. You may be contacted to complete your original proposal if needed. The Scientific Committee will be in charge of selecting contributions and making the programme based on the selected contributions. It will ensure a good balance between the different thematic entries. Gender balance and geographical origins will also be important.

Contributions that are not selected for the Pitch Corner will, however, be posted on the Cartography for Action on Climate Chance's website.

Submissions must meet the following 2 criteria:

- **Currently a non-state actor:** Businesses - Industry, Farmer Organisations, Indigenous Peoples Organisations, Local Authorities - Municipalities, Multi-stakeholder, NGO/ Non-Profit Organisations, Research and Science, Unions, Women Organisations - Gender, Youth Organisations
- **Have an ongoing project that integrates one of the 15 themes listed above:** Adaptation - Resilience, Biodiversity - Forests - Land Use, Climate Finance, Climate Negotiations, Economic Transition (Sustainable Supply Chains, Circular Economy, Employment), Education - Awareness-raising, Energy, Food - Agriculture, General, Mobility - Transport, Multi-level Governance, Oceans - Coastal Areas, Sustainable Housing - Building, Territorial Planning and Territorial Management, Water

Conditions of Contribution:

- The deadline for sending contributions is **February 14, 2022**.
- Contributions will be reviewed and selected by Climate Chance's Scientific Committee.

- Selected contributors will be contacted as early as the first week of February.
- Contributors are responsible for registering for the Climate Chance Summit Europe 2022.
- Contributors are also responsible for taking care of their registration, travel and accommodation.
- Contributions that are not selected will be contacted and informed by email and will not receive compensation benefits.
- The selected contributors authorise the Climate Chance Association to reuse and communicate their work, in compliance with copyright following the summit.
- The Climate Chance Summit Organizing Committee is the only decision-making body for all summit issues.
