Description / Description :

Depuis 2015, l'initiative ACT - Assessing low-Carbon Transition® a accompagné et évalué plus de 350 organisations avec des méthodologies prospectives et sectorielles pour délivrer des plans de transition climatique et juste crédibles. Cet atelier est une introduction à la méthodologie ACT-Adaptation, récemment publiée et développée par l'Ademe. La session vise à fournir aux participants des outils pratiques pour évaluer la stratégie d'adaptation de leur entreprise, afin de repérer les points forts et les opportunités d'amélioration. Elle s'appuiera également sur le retour d'expérience d'entreprises pilotes ayant expérimenté la méthodologie, et dressera des perspectives.

Since 2015, ACT – Assessing low-Carbon Transition® initiative has supported and assessed more than 350 organizations with future-oriented, sector specific methodologies to deliver credible climate and just transition plans. This workshop is an introduction to the newly released ACT-Adaptation methodology, developed by the Ademe. The session aims at providing attendees with practical tools to evaluate their companies' adaptation strategy, in order to spot strengths and opportunities for improvement. It will also draw on feedback from pilot companies having experienced the methodology, and set perspectives.
